- The completed nomination form, along with the appropriate fee and other supportive documents as specified when which was submitted in person/representative to the designated Election Commissioners by 8:00 pm on Tuesday, 16th September 2025. Both the proposer and seconder must be bona fide members of the same union or municipality as the candidate. The Election Commissioners will be available officially between 6:00pm and 8:00pm on Tuesday, 16th September 2025, at Children Education Group, Harkness House, 101 Christian St, London E1 1RX.
- Nomination fees: Chairman: £700 | General Secretary: £600 | Treasurer: £500 | Vice-Chair: £400 | Assistant General Secretary: £350 | Assistant Treasurer: £300 | Departmental Secretary: £300 | Assistant Departmental Secretary: £250 | EC Members: £200 nomination fees are to be paid in cash and are non-refundable.
- Any individual currently serving on the Executive Committee of any other Golapganj Upozila-based organisation shall not be eligible to contest for the position of Chair, Vice Chair, Secretary, Treasurer, or Departmental Secretary of this organisation. If they wish to participate, they must resign from the other organisation and provide an official acknowledgement along with their nomination.
- Only members who have held membership in the Charity for at least one year (i.e., on or before October 20th, 2024) are eligible to stand for election to the Executive Committee.
- Candidates running for Chairperson, General Secretary, and Treasurer positions must include a copy of their DBS (Disclosure and Barring Service) certificate with their completed nomination form. The closing date for withdrawal of nominations (in writing): 6pm, Saturday 20<sup>th</sup> Sept 2025.
- No individual shall be permitted to contest the Executive Committee (EC) election independently. Candidates must participate as part of a panel, with nominations for at least 15 positions, including 3 signatory roles.
