Amendment Proposal: 1

Current Clause 14(e):

"No one who has been a member of the Charity for less than six months shall be eligible to stand for election to the Executive Committee (EC)."

Proposed Amendment to Clause 14(e):

"No one who has been a member of the Charity for less than one year shall be eligible to stand for election to the Executive Committee (EC)."

Amendment Proposal: 2

Current Clause: 16(c)

"Immediately upon the completion of the election of the EC, the Election Commissioner(s) shall conduct the lottery at the same BGM to allocate posts to each UP for election for the next term, and thereafter their appointment as Election Commissioner(s) shall relinquish automatically."

Proposed Amendment to Clause: 16(c)

"Upon the election of the EC and the declaration of the results by the Election Commissioner(s), their appointment shall relinquish automatically.

Clause 16(h)

The lottery to allocate posts to each UP for election for the next term will be held at the AGM."

Proposed Amendment 3

No individual shall be permitted to contest the Executive Committee (EC) election independently. Candidates must participate as part of a panel, with nominations for at least 15 positions, including 3 signatory roles.

This clause will be added to election rules.

Membership Fee Update

Please be informed that the membership fee for the GHH shall be increased from one hundred pounds (£100) to two hundred pounds (£200). This change will take effect one month after the AGM.
